## BOOKS DONATION AND SCHOLARSHIPS AGREEMENT

THIS **BOOKS DONATIONS AND SCHOLARSHIPS AGREEMENT** is made this .....<sup>8<sup>th</sup></sup> day of OCTOBER.....Two Thousand and Twelve BETWEEN **RIGHT DESTITUTE MOTHER CHILD ORGANIZATION**, a non governmental organization duly registered in Kenya and of Post Office Box Number 749 – 00621, NAIROBI in the Republic of Kenya (hereinafter referred to as “**RT-DEMCO**”, which expression shall where the context so admits include its successors and assigns) of the one part AND **SOUTH EASTERN UNIVERSITY COLLEGE**, a Constituent College of the University of Nairobi duly registered with the Ministry of Higher Education, Science and Technology and of Post Office Box Number 170-90200 KITUI in the said Republic (hereinafter referred to as “**SEUCO**”, which expression shall where the context so admits include its successors and assigns ) of the other part.

### **WHEREAS:-**

- A. RT –DEMCO is a charitable organization engaged in the education and welfare of bright orphaned and poor children and has in its custody and care students who have qualified for diploma and undergraduate university courses but are unable to pay university tuition.
- B. SEUCO is a university college offering qualified students various degree and diploma courses.
- C. RT-DEMCO has received from its partners and donors three thousand (3000) assorted brand new volumes of books suitable as study and reference books for university level students and staff.
- D. SEUCO has offered to admit qualified students from RT-DEMCO to pursue undergraduate courses in its college on scholarship basis in exchange with the books and RT-DEMCO has accepted the offer on the terms and conditions stated herein.

### **NOW THIS AGREEMENT witnesseth as follows:-**

1. The value of the three thousand books is Kenya Shillings Fourteen Million One Hundred Thousand (Kshs. 14,100,000.00).
2. RT-DEMCO handed over and delivered the three thousand books to SEUCO before the execution of this agreement (receipt whereof SEUCO does hereby acknowledge).
3. In consideration for the donation of the books, SEUCO has offered RT-DEMCO six (6) full undergraduate scholarships.

4. The scholarships are by way of full waiver of tuition, statutory and accommodation fees such that each of the six (6) students shall undertake the studies free of charge.
5. In order for SEUCO to waive the fees for accommodation, the students must be admitted and registered at the SEUCO main campus at Kwa Vonza, Kitui.
6. Each of the six (6) students under the scholarships shall cater for his/her own upkeep and maintenance expenses.
7. The scholarships for each student are for the duration of the course which is four (4) years provided that if a student repeats an academic year, tuition, statutory and accommodation fees for the repeated year shall be borne and paid by the student so repeating the academic year or by RT-DEMCO.
8. To qualify for the scholarship, the students must have obtained a minimum grade of C+ (plus) in the Kenya Certificate of Secondary Education (KCSE) examinations and also met the requisite grades in the cluster subjects.
9. This agreement contains the entire understanding between the parties hereto in respect of the books donation and scholarships and replaces all previous written and oral agreements.


